Applications are invited from the eligible and meritorious Scouts & Guides candidates in the prescribed format (attached herewith) for filling up of 02 (Two) posts in PB-1 ₹.5200-20200/- with Grade Pay ₹ 1900/- and 06 (Six) posts in PB-1 ₹ 5200-20200/- with Grade Pay ₹1800/- against Scouts & Guides Quota: 2016-17 over South East Central Railway.

1. **DETAILS OF POSTS:**

2. **EDUCATIONAL QUALIFICATION:**

(I) FOR POSTS in PB-1 ₹ 5200-20200 with corresponding Grade Pay 1900/-.

12th (+2 stage) or its equivalent examination with not less than 50% marks in the aggregate. [50% marks is not to be insisted upon in case of ST/SC/Ex-Serviceman and for candidates who possess higher qualifications such as /Graduation/Post Graduation etc.]

(or)

Act Apprenticeship/ ITI. No other qualification including Diploma in Engineering will be accepted as an alternative qualification.

(II) FOR POSTS in PB-1; ₹ 5200-20200/- with corresponding Grade Pay ₹ 1800/-.

Minimum 10th pass or ITI or equivalent.

[Candidates should possess the qualification at the time of applying.]

3. SCOUTING/GUIDING QUALIFICATIONS:

{The following Scouting & Guiding qualification will be applicable for <u>both</u> posts in PB-1 ₹5200-20200/- with corresponding Grade Pay ₹1900/- and posts in PB-1 ₹ 5200-20200/- with corresponding Grade Pay ₹1800/-.}

Candidates should be:

- i. A President Scout/Guide/Rover/Ranger OR Himalayan Wood Badge (HWB) holder in any section.
- ii Should have been active member of Scouts Organization for the last five years. The 'Certificate of Activeness' should be as per Annexure-A; and
- iii Should have attended two events at National Level or All Indian Railways Level AND two events at State Level.

[Note: Candidates having no Scout & Guide qualifications as at 3 above need not apply.]

4. AGE LIMITS:

4.1 FOR POSTS in PB-1 ₹5200-20200 with corresponding Grade Pay ₹1900/-.

Candidates should have attained age of 18 years and should not have completed 29 years as on **01.01.2017**. The upper age is relaxable by 03 years for candidates belonging to OBC communities, & by 05 years for candidates belonging to SC/ST communities.

FOR POSTS in PB-1 ₹ 5200-20200/- with corresponding Grade Pay ₹ 1800/-.-

Candidates should have attained age of 18 years and should not have completed 32 years as on **01.01.2017**. The upper age is relaxable by 03 years for candidates belonging to OBC communities and by 05 years for candidates belonging to SC/ST communities.

4.2.3 Persons who had ordinarily domiciled in the Kashmir Division of the State of Jammu and Kashmir during the period from 1st.January'1980 to 31st. December'1989 by 5 years.

- 4.2.4 Staff of quashi Administrative Offices of Railway Organizations: Relaxation of age will be to the extent of 5 years (or) service rendered by them in such organizations whichever is less.
- 4.2.5 Ex-servicemen candidates: Relaxation of age will be to the extent of service rendered by them in Defence services plus 3 years provided they have put in a minimum of 06 months service after attestation and up to the age of 40 years for reservists not employed in Government Service.

4.2.6 **Persons with Disability:**

Note: (i) Specific category and place of posting will be decided by the South East Central Railway Administration at the time of offering appointment to the selected candidate.

- (ii) The community breakup of the posts notified will be decided at the time of offer of appointment based on the community of the selected candidates. Accordingly all the eligible candidates belonging to all categories (UR, OBC, SC/ST etc.) may apply for the posts notified.
- (iii) Candidates belonging to SC/ST communities should produce a community certificate in the format given in Annexure-D of this Notification.
- (iv) Candidates belonging to OBC community should produce a community certificate in the format given in Annexure-E of this Notification. In addition the OBC candidates should enclose self-declaration of non-creamy layer status in the proforma given in Annexure-F.
- (v) Serving employee and Staff of Quasi administrative offices of Railway Organizations: "No Objection Certificate" and "Bonafide Certificate" giving the length of regular service etc. from the employer should be attached.
- (vi) Divorced/Judicially separated Women: Copy of Decree from the competent court of law for having divorced/judicially separated along with an Affidavit that she has not remarried since should be enclosed.
- (vii) Widow: Death certificate of her husband together with an Affidavit has not remarried since should be enclosed.
- (viii) Ex-Servicemen: Discharge certificate should be enclosed.
- (ix) Persons with Disability: Competent Authority to issue a Disability Certificate shall be a Medical Board duly constituted by Central or State Government consisting of at least three members out of which at least one shall be specialist in the particular field for assessing Locomotor/Cerebral/Visual/Hearing Disability, as the case may be.

5 HOW TO APPLY:

- i) Candidates should apply in the enclosed format. The application should be filled in own hand writing. One passport size photograph of the candidate should be pasted in the specified space on the application form, duly signed on the top by the candidate.
- ii) One passport size photographs (same as fixed in the application form) duly signed on the top should be clipped along with the application form.
- iii) All copies of certificates in support of age, caste, educational qualification, other qualification should be self attested and enclosed along with the application form.
- iv) Copies of certificates in proof of participating in Scouts/ Guides activities should be countersigned by Dist. Commissioner/Scouts or Dist. Commissioner/Guides for respective wings and 'Certificate of Activeness' for the last five years and continuation certificate as active member be signed by the State/District Commissioner (Scouts) for scouts wing and State/District Commissioner (Guides) for guides wing and enclosed along with the application form.
- v) **Examination Fees:**
 - (i) For all candidates except those mentioned in sub para (ii) below :₹ 500/- (Rupees __ Five Hundred only)
 - (ii) For Candidates belonging to SC/ST communities, Women, Ex-Servicemen, Minorities {Muslim, Christians, Sikhs, Buddhists and Zoroastrians (Parsis)}, Persons With Disabilities, and those belonging to economically backward classes: ₹ 250/- (Two Hundred Fifty Only) refundable to those Who actually appear in the written examination.

The fee is Payable through Challan on State Banks of India, Main Branch, Bilaspur {(C.G) Branch Code No. 0336} against Railway Recruitment Cell/SECR/Bilaspur's Account No. 33344526197 through any Branch of State Bank of India [FORMAT OF CHALLAN IS AVAILABLE AT ANNEX. (H) OF THIS NOTIFICATION.) The candidates applying for both the posts (i.e. GP 1900 and GP 1800) have to pay the fees separately.

Candidates belonging to economically backward classes mean the candidates whose family income is less than 50,000/- per annum. The following authorities are authorized to issue income certificates for the purpose of identifying economically backward classes:

- a) **District** Magistrate or any other Revenue Officer up to the level of Tahsildar.
- b) Sitting Members of Parliament of Lok Sabha for persons of their own constituency.
- c) Union Minister may also recommend for any persons from anywhere in the country.
- d) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.

Note: BPL Card or any other certificate issued by Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways will also be valid.

- vi) The certificate for refund of fee in respect of candidates belonging to economically backward classes who actually appear in the written examination is required to be issued on the letter head of the issuing authority as per the format enclosed as **Annexure `C'**.
- vii) Serving employees should submit their applications through proper channel as per extant rules.
- viii) More than one application in one envelope and more than one application for same category from one candidate will be summarily rejected.
