- (3) MINIMUM EDUCATIONAL QUALIFICATION: (A) For the posts having GP.1900/2000: Pass in 10+2 or its Equivalent (B) For the posts having GP-2400/- (Technical): Pass 10+2 in Science i.e. Maths or Physics or equivalent. (C) For the posts having GP 2800/-: A university Degree or its equivalent.
- (4) AGE: 18-25 years as on 01.01.2017. No age relaxation is permissible.
- (5) PERIOD OF RECKONING OF SPORTS ACHIEVEMENTS: The sports achievements of current & previous two financial years will be taken into account for eligibility. Therefore, the sports achievements of on or after 1<sup>st</sup> April 2014 will only be considered.
- (7) How To apply: (i) Candidate should carefully read all the instructions given in the employment notice before filling the application form. (ii) Application shall be submitted on good quality white plain A4 size paper in the format given in Annexure-A hereunder using only one side of the paper. (iii) The application should be filled either in English or Hindi. (iv) The application form should be filled by the applicant in his/her own handwriting using a blue or black ball point pen. (v) Serving Government employees should send their applications through proper channel duly forwarded by their controlling officers. The last date will not be extended on account of delay in transmission of the application by the concerned office. However an advance copy of the application may also be submitted. (vi) Candidates claiming refund of Examination Fee must submit self attested copies of the requisite certificates, issued by the appropriate authority.
- (8)Whom to apply: Application in the prescribed format, complete in all respect along with all the enclosures should be sent by ORDINARY POST only to Senior Personal Officer, Railway Recruitment Cell, N.E. Railway CCM Annexe Building Railway Road No. 14 Gorakhpur (UP)-273012 or may be dropped in the box kept at the premises of Railway Recruitment Cell, Gorakhpur between 09.30 hrs to 18.00 hrs. on any working day on or before last date of application in an envelope duly superscribing "SPORTS QUOTA 2016-17"
- (8) Examination Fee: (i) For all candidates except those mentioned in sub-para (ii) below: Rs.500/-(Rupees Five Hundred only). (ii) For candidates belonging to SC/ST/Ex-servicemen/Persons with disabilities (PWDs), Women, Minorities and Economically Backward Classes: Rs-250/-(Rs. Two Hundred Fifty only), which will be refunded to those candidates who actually appear in the trials. Fee will be in the form of Indian Postal Order (IPO), drawn in favour of Senior Personnel Officer, RRC, N.E. Railway, payable at Gorakhpur. IPOs issued before the date of issue of this Employment Notice will not be accepted and the Application form will be rejected. Applications received with fee in the form of Demand draft/Cash/Cheque/Central Recruitment Fee Stamps and Money Orders will not be accepted and application form will be REJECTED. Candidates must write their name and full address at the space provided in the postal order. Save as stated above, the examination fee is not refundable/transferable/adjustable under any circumstances.
- (09) RECRUITMENT PROCESS: The recruitment will be based on performance in trial and evaluation of sports and educational achievements.
- (10) GENERAL CONDITIONS OF RECRUITMENT: (i) Before applying, the candidate should ensure that he/she fulfills all the eligibility norms (ii) The specific position played in the particular game/event if applicable must be mention in the application form. (iii) The educational or Sports qualifications acquired after the date of application shall not be considered. (iv) Candidates attempting to give false information/suppressing the facts will be disqualified and are liable for debarment and legal action. Candidates who attempt fraud/impersonation are liable to

be debarred to appear in the future examinations conducted for recruitment in Railways. (v) Candidate(s) found eligible for appointment have to pass the prescribed medical examination conducted by the Railway administration before appointment. (vi) Mere selection of candidates and recommendation for their appointment shall not confer any right on the candidates for their appointment in Railway. (vii) Second class Free journey pass from the nearest Railway station mentioned in the application form will be issued to the candidates belonging to SC & ST communities whenever they are called at any stage of recruitment. (viii) The person appointed against Sports Quota to the category of clerks will be required to possess proficiency in typing within a period of four years from the date of appointment. If the candidate does not acquire prescribed typing qualification within the stipulated period, increments due after four years and thereafter shall not be released. (ix) Candidates belonging to Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahoul and Spiti districts and Pangi Sub-division of Chamba District of Himachal Pradesh, Andaman & Nikobar and Lakshwadeep Islands should enclose a domicile certificate or a certificate of having passed the qualifying examination from the school/college situated therein.(x) Candidate should be in readiness to appear in the trials at short notice.
