The envelope should clearly mention the senders name and complete address at the reverse.

5. Last date for receipt of application is 21 days from the date of publication of the advertisement in the Employment News (including the date of publication).

6. The crucial date for determining the age limit shall be the closing date for receipt of application i.e, 21 days from publication in Employment news.
